This article explains the report in community service of training in writing English couplets for students of SMAN 19 Surabaya in 2024. Couplets are one of English literary works, especially poems, in which two lines of verse are joined in a rhyme. Writing couplets is important to dig understanding about both indications of structures in English poems alongside students' creative imaginations. Structuralism is a perspective that underlines analysis of structures in English language, especially through English literary works. It is also known that structure in English language is meant to be universal rather than particular. Through an exploratory approach within qualitative research, this manuscript underscores structuralism as a way to identify aspects of literature regarding training of writing couplets. Couplet is a work that pays attention to pouring imaginations from the authors' mind towards a structured sense of lyrical poem. Though the ideas come from various authors' imaginations, this kind of literature and its writing process may still open to various possibilities in advance. In conclusion, the training of writing couplets is essential not only to give knowledge about patterns of poems in English literature, but also to get it in line with students' everyday experience and imaginations.

For instance, couplets are typified by rhyming poems with two stanzas. There may be six or eight stanzas in the writing. Even though many English language learners are aware of this kind of work, they are still used to feel ashamed and incapable of producing couplets or other similar works.

Community service is essential to emphasis the distribution of scholarly information to bigger audiences. English literature classes also make advantage of this idea, especially when pushing senior high school students to study couplets more. In a nutshell, this page describes the community work that Sekolah Menengah Atas Negeri (SMAN) 19 Surabaya students accomplished in 2024. The major objective of this exercise is to teach students how to use their own creative ideas to write these couplets. This is also intended to foster their creativity, especially in the area of writing literary works that draw inspiration from the difficulties they face on a daily basis.

This community service initiative represents a distinctly defined methodology through which students are afforded the opportunity to enhance their awareness and understanding of recurring themes and motifs that permeate English literary works, thereby fostering a deeper appreciation for the nuances of literary expression (Chen, 2023; Givens, 2023; Nasiri et al., 2023). Structuralism, as a theoretical framework, serves as a pivotal point of reference that enables individuals to grasp the universal characteristics of literature, particularly by examining the intricate interplay of linguistic signs and the normative conventions that are systematically imparted within educational contexts. The act of composing couplets can also signify the application of such sophisticated literary principles to the realm of imaginative writing, thereby bridging the gap between theoretical knowledge and creative expression.

This practice may appear to be straightforward on the surface; it possesses a considerable depth that invites further exploration and analysis. Couplets specialize in the unique ability to intertwine elements of creative imagination with the tangible realities of everyday life, all while employing the rhythmic quality of rhyme to enhance their aesthetic appeal (Chen, 2023; Givens, 2023; Nasiri et al., 2023). By engaging in the craft of couplet writing, students can substantially elevate their proficiency in the English language—particularly in the domain of writing—by effectively integrating these two vital components. Furthermore, the practice of writing couplets not only bolsters one's writing skills but also contributes to the enhancement of various other facets of English language competency, including but not limited to vocabulary development, grammatical accuracy, and the proficient use of clauses and phrases within written discourse.

## METHOD

The objective of this community service initiative is to enhance awareness of English literary couplet structures. It is specifically designed to instruct senior high school students at SMA Negeri 19 Surabaya in the art of couplet composition. Despite these students demonstrating robust cognitive skills in the English language, they exhibit a deficiency in practical application, which is reflected in their everyday experiences. This discrepancy largely arises from the perception that English holds less utility in quotidian contexts compared to its significance in formal educational environments. Consequently, this community service adopts a targeted methodology aimed at augmenting their proficiency in the English language, with a particular focus on writing. The preparatory phase of this community engagement entails a collaborative relationship with the school, facilitating students in composing couplets, as well as evaluating the finished couplets for potential future applications.

## FINDINGS AND DISCUSSIONS

#### Writing Couplets and Its Relations to Structuralism

Any writer can convey their own aim and provide significance through their writing. Literature, then, is about the author's expanded and poured imagination into writing (Baxodirovna, 2024; Kenjabaev, 2024; Wijaya et al., 2024). It is never what it seems; instead, it functions and provides details based on real-world experiences. The reason for this is that literature reflects the identities of people. Furthermore, in everyday situations, people's identities will never change from their original state. Additionally, literature is a means of connecting the real world with the imaginary one (Baxodirovna, 2024; Kenjabaev, 2024; Pasopati et al., 2024). It provides broader viewpoints for how identities manifest in relation to its ongoing actualizations of broader challenges.

In short, the structuralism approach sees poetry as similar to other written works, especially with regard to a shared vocabulary and symbolic system. It centers on the study of poetry's structure. By using this approach, each poem may be understood as interacting with other models of organized poetry, rather than as a stand-alone poem (Chen, 2023; Givens, 2023; Nasiri et al., 2023). Similarities with other poems can also be seen, for instance, in recurring and well known common sense symbols' rhyming, meter, and linguistic features. Whatever its subject, poetry always makes reference to other poems, not to the outer world, according to structuralism.

The central premise of structuralism revolves around the concept of deciphering and comprehending the intricate frameworks that underpin literary texts. This theoretical approach aims to elucidate that the recurring motifs and frameworks are articulated in a manner that transcends individual variability, illustrating universality inherent within the literary domain (Chen, 2023; Givens, 2023; Nasiri et al., 2023). Furthermore, it is posited that the structuralist perspective asserts the existence of discernible patterns that can be identified across a diverse array of literary compositions. Such patterns encompass various elements, including structural form, lexical choices, and the use of metaphorical language prevalent in poetic works, all of which play a significant role in shaping the essential architecture of the text (Hunter, 2023; Givens, 2023; Nedaei et al., 2023). Structuralism explores the construction of meaning through language signs and established rules, ignoring the author's reality or history in favor of focusing primarily on patterns in literary works. Couplet writing, which is a very conventional writing style, also reflects this structuralism viewpoint. The beauty of this kind of poetry may still be appreciated even when it has been in context for a while because it has a straightforward structure but a deep meaning (Wort, 2023; Hunter, 2023).

A couplet is defined as a pair of sequential lines of poetry that are intricately interconnected through the shared elements of rhyme and rhythmic structure, thus creating a harmonious relationship between them. The intentional incorporation of rhythm along with the use of lyrical language serves to invigorate and animate a poem, imbuing it with a dynamic quality that captivates the reader's imagination (Chen, 2023; Givens, 2023; Nasiri et al., 2023). Additionally, a couplet may also denote two successive lines of verse that collectively complete a thought or convey a cohesive idea, thereby enhancing the overall meaning of the text. These lines often adhere to a specific metrical pattern, which reflects a consistent syllabic cadence that contributes to the musicality of the verse.

While it is important to note that not every couplet adheres to a rhyming scheme, it is indeed the case that a significant majority of them do exhibit this characteristic. A couplet possesses the remarkable versatility to exist as an independent poetic form or to be integrated seamlessly into a larger poetic composition, demonstrating its flexibility and adaptability in various literary contexts (Chen, 2023; Givens, 2023; Nasiri et al., 2023). Moreover, the use of rhyme within a couplet is instrumental in crafting vivid and imaginative imagery, through which readers can discern a multitude of nuanced linguistic and literary meanings that enrich the interpretative experience.



Pink flower is about sweetness in which someone never wants to lose the other but the reality speaks differently. It is ended with a couplet about High School crush that colors the love at school. It is when a girl falls in love with a guy in the same school and it makes the person awkward every time they meet. Octavia's couplets may have the same topic of love in its structure. Meanwhile, her expression may be different regarding any emotion she embraces within. This is the looseness of meanings that is being kept in structure of literary works.
